## 7.1 PRECAUTIONS FOR SAFE HANDLING:

### 8.2 **EXPOSURE CONTROLS:**

## **ENGINEERING MEASURES:**





Provide adequate ventilation. Where reasonably practicable, this should be achieved by the use of local exhaust ventilation and good general extraction. If these measures are not sufficient to maintain concentrations of particulates and vapours below the Occupational Exposure Limits, suitable respiratory protection must be worn.

Protection of respiratory system: Avoid the inhalation of vapours.

Protection of eyes and face: It is recommended to install water taps or sources with clean water close to the working area.

Protection of hands and skin: It is recommended to install water taps or sources with clean water close to the working area. Barrier creams may help to

protect the exposed areas of the skin. Barrier creams should not be applied once exposure has occurred.

## OCCUPATIONAL EXPOSURE CONTROLS: Regulation (EU) No. 2016/425:
